WAHVM Congress, Engelberg, Switzerland

Dr. Susan Jones, AVMHS Delegate to WAHVM, and four other Americans presented papers at the WAHVM International Congress held in Engelberg, Switzerland on Sept. 11-14, 2008. They were Fred Born, Brian Caton, Lesley Ann Gentry, and Michael Mackay. Dr. Jones' full report of this congress, held in the beautiful, small town pictured at the right, will appear in the November issue of *Veterinary Heritage* later this fall.

Of special importance to AVMHS was the election of Dr. Susan Jones as a WAHVM co-president through 2012 with Peter Koolmees of The Netherlands. This required the AVMHS Board to name another member to serve as its delegate on the WAHVM Liaison Committee to work toward the 2010 Congress in Turkey. Our Society has already named Lesley Ann Gentry of Beliot, Kansas to complete Dr. Jones' term through 2010.

Another AVMHS member, Philip Teigen, was elected WAHVM Secretary. Historian Teigen is Deputy Chief of the History of Medicine Division at the U.S. National Library of Medicine. Also at Engelberg, Dr. Guus Mathijssen reported on progress of the WAHVM committee responsible for building an *International Dictionary of Veterinary Biography*. They commended our AVMHS Secretary, Susanne Whitaker, for her work promoting this project and collecting American autobiographies. Secretary-Treasurer Whitaker has put together a "pick list" and time-line of nearly 200 prominent deceased veterinarians or non-veterinarians who contributed to veterinary medicine between 1740 and the present, and about whom biographies might be written. The costs versus values of having an AVMHS exhibit booth at the AVMA convention were debated. It was decided to continue to have a booth, but that expenses needed to be reviewed and kept to a minimum.
