## History Talk at AVMA by Dr. Murphy

AVMHS members going to the AVMA Convention in Austin, Texas will surely want to attend a presentation (Session #1180) by Monica Murphy, DVM, MPH, DACVPM on Tuesday, June 25, 2024 from 10:00am-10:25am CDT in Room 9AB Austin Convention Center. She will be speaking on "Vanguard in America's Vaccine Wars: The Nineteenth-Century Veterinarian." According to the program listing, this appears to be the only history presentation on the program schedule.

Her presentation is described as follows:


"Even as Louis Pasteur and his colleagues were developing the first laboratory-derived vaccines for human and animal diseases in Europe, American activists (including the pioneering animal welfare advocate, Henry Bergh (1813-1888)) attacked the science and the practice of immunization on moral and medical grounds. Echoes of nineteenth-century arguments against vaccination can still be heard today. Then, as now, veterinarians thrust themselves into the middle of the battle between science and skepticism, taking a stand on behalf of both animal and human health."

In planning ahead for the 2025 Convention in Washington, D.C., August 8-12, 2025, members might consider submitting a proposal for an oral presentation or

an electronic poster. Posters are an excellent means of highlighting historical topics in veterinary medicine visually in illustrations and minimal words. We have learned that the deadline for submitting poster proposals as "Hot Topics" is in early January 2025.

#### Dr. Monica Murphy's New Book

We are thrilled to learn that AVMHS member Dr. Monica Murphy with Bill Wasik have authored another

Dr. Shannon Greeley (<u>animalassociate@aol.com</u>) had been involved in making initial arrangements but was unable to attend as intended at last minute.

Like last year, Dr. Aiello reports that "SAVMA was a productive and good time!" She said she met many young and enthusiastic students who were interested in history. Even though most were not aware of the Society, they made positive comments. A few knew about AVMHS from having received a copy of *Guideposts* at their college's white coat ceremonies. Yet, Dr. Aiello felt the general level of interest was high.

About 44 students signed up at our table for more information about the essay contest and AVMHS in general and took one of Dr. Greeley's attractive tasseled bookmarks. "The bookmarks were a hit!"

Hosted by a different veterinary college each year, the 2025 SAVMA Symposium will be held in California at the University of California Davis in March 2025. Because reaching out to veterinary students entering their professional careers is important, it is hoped that one or more AVMHS members in the region might volunteer to host and staff a table at that meeting as well.

#### News from the Museum Committee

Chair Dr. Zbig Wojcinski (<u>zwwojcinski@gmail.com</u>) reports that the Museum Committee, consisting of 12 AVMHS members, has been meeting regularly via Zoom. The committee has responded to queries from the public seeking information concerning books and artefacts, as well as the identification of instruments. The Committee is also working toward updating the museum directory as well as determining how best to seek placement sources for "re-homing" and preserving books and memorabilia. For example, Dr. Fred Born is pursuing adding QR codes to veterinary museum listings. The intent is to use various technologies, such as *Constant Contact* and/or survey tools, to facilitate contacting organizations such as universities, museums, and VMAs.

Based on an inquiry received regarding a list of veterinary-related historical markers, the Museum Committee has recently become involved in a new role for recognizing the importance and potential of historical markers related to veterinary medicine. A sub-committee, composed of Fred Born, Howard Erickson, Shannon Greeley, and Susanne Whitaker, has been formed to begin addressing issues concerning such markers. Use and coordination with the Historical Markers database (HMdb) (https://www.hmdb.org/) is is being investigated. For a preview, please see the preliminary webpage created on the AVMHS website (https://www.avmhs.org/veterinary-historical-markers).

In addition, because grave markers do not generally include historical narratives, the sub-committee's interest has extended into exploring Memorials and Grave Site Markers for prominent veterinarians. Similarly, a separate webpage on the AVMHS website has been created (https://www.avmhs.org/memorial-gravesites), and efforts will be coordinated with *Find-a-Grave*, a subsidiary database of *Ancestry.com*.

There is also consideration being given to grave sites lacking markers, such as for Dr. Mignon Nicholson in Chicago. Collecting and encouraging the installation of historical markers along with location of memorials related to prominent veterinarians offer exciting and valuable opportunities to the Society for outreach.

Any other members interested in any aspect of markers and memorials should contact Dr. Zbig Wojcinski. Your participation will be most welcome.

## K-State Honors for Dr. Howard Erickson

Congratulations to Dr. Howard Erickson! He was recently designated the Kansas State University College of Veterinary Medicine's 2024 Alumni Fellow. This is the highest honor awarded to recognize alumni who have distinguished themselves in their careers.

After the seminar held on April 17, University President Richard Linton presented the award at a ceremony the next day on April 18 accompanied by Hodes Family College Dean Bonnie Rush. Over 115 people attended, including Dr. Erickson's wife, Ann, his sons, Jim and David, and many emeritus professors. Dr. Erickson's lecture was titled, "*Mentors, Colleagues, and Home Town Legends.*"

#### Appreciation Book for 2023 Essayists

The Society has a long-standing tradition of thanking every student who enters the annual Smithcors Student Veterinary History Essay Contest typically with a book and personalized bookplate. All 26 students who submitted papers in spring 2023 have been sent a copy of Mim Eichler Rivas' book, *Beautiful Jim Key: The Lost History of the World's Smartest Horse*.

This is a true story of an "educated" Arabian-Hambletonian horse (1889-1912) patiently and kindly taught to spell, read, write his name on a blackboard, tell time, count, do arithmetic, make coin change, sort mail, identify playing cards, cite Bible passages, and perform other feats by Dr. William Key (1833-1909).

Born a slave in Tennessee with a remarkable talent for working with horses and mules, Dr. Key read veterinary texts extensively and experimented with animal remedies to become a successful self-taught veterinarian and equine dentist. Managed by Albert R. Rogers, Jim Key and Doc Bill Key traveled widely across the country for 9 years exhibiting Jim's talents, including being one of the most popular attractions at the 1904 St. Louis World's Fair.

"Originally published in 1990, this book is a valuable contribution to the history of the veterinary profession in Great Britain and Ireland. Connie Ford's book is a reminder of the great social changes that have taken place since Aleen Cust was born in 1868. When Aleen Cust entered the New Veterinary College, Edinburgh in 1895, and was later refused permission to sit the examinations of the Royal College of Veterinary Surgeons, no British woman had the vote. To the women students, only admitted to the London Veterinary College in 1927, she was a legend and an example. Now, a new generation of veterinarians, will find this account of the life and times of a truly remarkable woman a revelation."

This article reveals, however, that eighteenth-century Britain was home to a thriving canine medical marketplace. Among its key actors were 'dog doctors' — individuals without formal healthcare training who regularly treated and healed dogs. This article offers the first historical account of the eighteenth-century dog doctor, contextualising and reappraising his identity, clients and services. It focusses on the dynamic career of the celebrity practitioner John Norborn, who proudly self-identified as a 'dog doctor' when the term was considered an insult.
